# Village Transition Begins Troutman Tapped to Lead Village

Waterfront Village Board President Carroll Quinn announced the selection of Assistant Director Pam Troutman as the Village's new executive director beginning January 1, 2024.



The announcement was made at the Peach Festival on August 21, 2023, on the patio of St. Matthew Lutheran Church. The decision was made after several months of deliberation and negotiation by the Board. Troutman will work with current Executive Director Len Bechtel to ensure a smooth transition before Bechtel retires on December 29, the last workday of 2023.

"After considering all of our options, the Board decided that the best thing we could do for the Village was offer Pam the executive director's job when Len leaves," Quinn said. "She is doing a great job now, knows many of the ins and outs of operating a village, and will ensure continuity and future success." Troutman got her start as a care manager at Iona Senior Services and spent several years leading social work teams that provided support to people aging in place and their family caregivers in Philadelphia.

Troutman started working for the Village in June 2021 and has been responsible for connecting volunteers with members who request services and hosting many of the Village's programs and activities.

"Other than Pam, I would be hard pressed to name someone who could step in here and not skip a beat. Members should feel very confident that the Village will continue to evolve in positive ways," said Bechtel. Bechtel's position is just one of the key leadership roles turning over later this year. President Quinn's term as a Board member will expire this year, making her ineligible to continue in the president's role. The Village is currently recruiting new Board members and is open to suggestions of potential community leaders who could serve a three-year term.

# IRA Distributions Given to Charity Can Lower Tax Bills

Many older adults who have made tax-deferred investments through Individual Retirement Accounts (IRAs) can lower their tax bills and

still help others by donating a portion of their required minimum distributions to a charity.

As we enter the second half of 2023, many of you may now be planning your end-of-year donations. If you're 72 or over, you also may need to take required minimum distributions (RMDs) from your individual retirement accounts (IRAs). Given recent tax changes, these decisions should be considered together.

Many IRA holders are unaware that they may make donations directly from their IRA to qualified charities and avoid taxes on those contributions. The IRS permits a direct transfer of up to \$100,000 from an IRA to a qualified charity. This transfer is called a Qualified Charitable Distribution (QCD). While IRA distributions are typically included as taxable income, QCDs are excluded from income while still counting towards your required distribution.

If you are open to helping non-profit organizations using QCDs, we are hopeful that you will consider donating to the Waterfront Village (WFV) or another non-profit you support. Your donation will help us fulfill our vision of a Waterfront Village that empowers its members to age with dignity, engage actively with their neighbors and community, and enjoy their desired quality of life in their own homes.



A QCD must be paid directly from your IRA to a qualified charity. You can also donate part of your required minimum distribution to charity and withdraw the rest as income. Funds withdrawn as income will be taxed.


For individuals who can use QCDs, they are likely the most tax advantageous way to give to charity. Note that QCDs can only be made from IRAs and not from employer retirement plans such as the Thrift Savings Plan (TSP). To make a QCD to the Village, contact the broker, financial advisor or custodian for your IRA. They will provide you with the required form and directions.

### **New Class Seeks to Tap Your Creativity**

### Metro Access - Why I Use It and Why You Should Too! Monday, September 18 1:00 p.m. via Zoom


This presentation will be brought to you by member Rachel Hecht, who has recently begun

# **Book Club**Why the Innocent Plead Guilty and the Guilty Go Free by Jed S. Rakoff

## Thursday September 21, 2:00 p.m. at the SW Library



Federal judge Jed S. Rakoff, a leading authority on white-collar crime, explores a variety of legal conundrumss in *Why the Innocent Plead Guilty and the Guilty Go Free*, a startling account of our broken legal system. Grounded in Rakoff's twenty-four years as a federal trial judge in New York in addition to the many years he worked as a federal prosecutor and criminal defense lawyer, Rakoff 's assessment of our justice system illuminates some of our most urgent legal, social, and political issues: plea deals and class-action lawsuits, corporate impunity and the death penalty, the perils of eyewitness testimony and forensic science, the war on terror and the expanding reach of the executive branch. A fundamental problem, he reveals, is that the judiciary is constraining its own constitutional powers.

Like few others, Rakoff understands the values that animate the best aspects of our legal system—and has a close-up view of our failure to live up to these ideals. But he sees within this gap great opportunities for practical reform, and a public mandate to make our justice system truly just.


### Great Decisions: Iran at a Crossroads Friday September 22, 12:45 p.m. at the Southwest Library
